Based on the recommendations of the University Inspection Committee, Sanction is hereby accorded for grant of extension of provisional affiliation to **MSS Law College, Chaderghat, Hyderabad** (College Code: 1725) to offer **LLM (Corporate & Securities Laws) Course**, with an intake of **(20)** students for the academic year 2025-2026. However, the college has to fulfill the following conditions/deficiencies.

**Conditions:**

1. The College has to appoint Teachers, through a duly constituted Selection Committee as per OU norms and obtain University approval.
2. Eleven (11) teachers has to be ratified by the University.
3. Books worth Rs. 5,00,000/- has to be procured.
4. Ten (10) Computer with latest configuration has to be procured.
5. As per norms of the BCI, the salaries of faculty have to be paid as per UGC Pay scales, at least Basic pay of the scale. Therefore, advised to hike a minimum of Rs. 10,000/- per month to all the faculty.
6. The building permission for 3<sup>rd</sup> and 4<sup>th</sup> floors should be obtained and certified by the competent authority.
7. Salaries of the Staff to be paid through Bank only.
8. Three Governing body meetings associating University nominee to be conducted in a year.
9. The Faculty to be deputed for Refresher Courses / Orientation Programmes / Faculty Development Programs conducted by the Osmania University.
