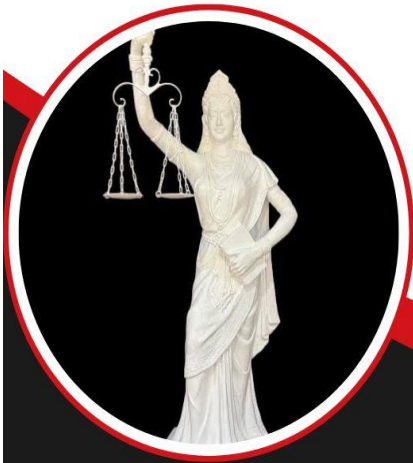

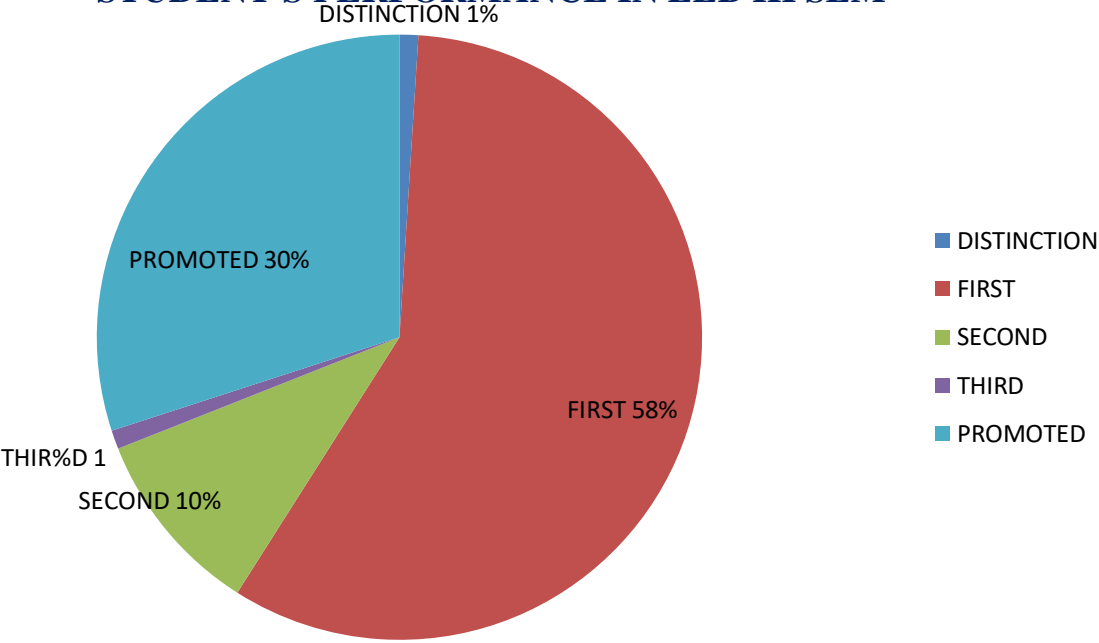

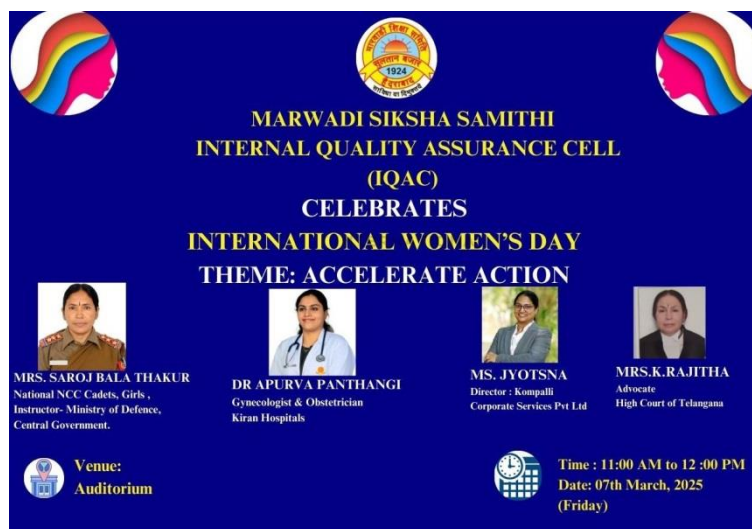

Hon'ble Justice Dr. G. Radha Rani, Judge, High Court of Telangana, Madam delivered an insightful talk on international taxation, focusing on the complexities of cross-border transactions and the need for equitable tax practices. She discussed relevant constitutional provisions like Article 265, which mandates that no tax shall be levied or collected except by authority of law, and emphasized India's commitment to international tax treaties under Article 253. Referring to landmark Supreme Court cases such as *Azadi Bachao*

Andolan v. Union of India, which upheld the validity of Double Taxation Avoidance Agreements (DTAA), and *Vodafone International Holdings v. Union of India*, which clarified tax liability in cross-border mergers, she highlighted the evolving jurisprudence in international taxation and its global implications.



Hon'ble Justice Mrs. T. Madhavi , Judge, High Court of Telangana

Madam delivered a powerful address on gender justice, highlighting the constitutional commitment to equality and dignity for women. She emphasized key provisions such as Articles 14, 15(3), and 21, which ensure equal protection, allow for affirmative action, and guarantee the right to live with dignity. Citing landmark Supreme Court judgments like *Vishaka v. State of Rajasthan* (on workplace harassment), *Golaknath v. State of Punjab* (on fundamental rights), and *Joseph Shine v. Union of India* (striking down adultery law), she illustrated how judicial interpretation has strengthened women's rights and advanced gender justice in India.

Madam emphasized the foundational role of Articles 14, 15, and 21 of the Indian Constitution in safeguarding equality, non-discrimination, and the right to life and personal liberty. She highlighted landmark Supreme Court judgments such as *Maneka Gandhi v. Union of India*, which broadened the scope of Article 21; *Indira Sawhney v. Union of India*, interpreting reservations under Article 15; and *E.P. Royappa v. State of Tamil Nadu*, which reinforced the dynamic interpretation of Article 14. Her speech underscored how these articles continue to be the bedrock of constitutional justice in India.

Theme – “75 Years of the Supreme Court: Guardians of Rights, Guides of Governance.

Session was chaired by

Dr. N Ramprasad delivered an insightful address focusing on Part III and Part IV of the Constitution of India, emphasizing the interplay between Fundamental Rights and Directive Principles of State Policy. He elaborated on the essence of Articles 14, 19, 21, and 32, stressing that equality under Article 14 is a dynamic concept, illustrated through landmark cases such as the Sarpanch case and E.P. Royappa v. State of Tamil Nadu, where the Supreme Court upheld the principle of rule of law and equality in governance.

On Article 21, Dr. Ramprasad highlighted its broad interpretation, covering speedy trial, free legal aid, dignity in custody, clean environment, and the right to education, citing the Unnikrishnan case. He emphasized the constitutional vision of solidarity and the State's role as custodian of citizens' rights.

In relation to Article 32, he reflected on its significance as the constitutional remedy for enforcement of rights. He also touched upon Article 51 and its relevance to India's foreign policy. His address concluded with contemporary concerns on digital privacy, urging alignment of rights with emerging technologies.

Technical Session I was co -chaired by Adv. Ms. Priya Iyengar, CEO of Compass Law Associates. In her address, Adv. Iyengar highlighted the Supreme Court's pivotal role in ensuring justice to the common man, describing it as the ultimate instrument for achieving social justice in India. She reflected on how the Supreme Court serves as the last door to knock for those seeking remedies against injustice. Adv. Iyengar also spoke about the challenges faced by young advocates and practicing lawyers, emphasizing the need for institutional support, mentorship, and reforms to enable the legal fraternity to serve society effectively. She underscored the importance of upholding the faith of the common people in the judiciary, as the Supreme Court continues to be a beacon of hope for millions. The session inspired participants to reflect on the vital role of the judiciary in strengthening democracy.

A Total of 6 papers were presented in this session Speakers presented on Public Interest Litigations (PIL) adjudicated by The Supreme Court, Balancing Judicial Power and Judicial Activism in the Interpretation of Constitution and its landmark judgments paved the way for new enactments and amendments to the existing laws. Speakers addressed questions from the panel of Judges appropriate answers were given along with valuable insights and Supreme Court

Citations. The Session concluded with key takeaways and suggestions from the session chairs were thought-provoking.

All the presentations emphasized that Justice delivery system by the Bench shall be in strict reference to the academic books, law of the land and constitutional framework.

Ms Vasudha Nagaraj : - Advocate Vasundhara Nagaraj highlighted the challenges and evolving dynamics in family law practice. She noted that although the number of family courts has increased, the field of family law is often looked down upon and lacks encouragement. With more women now being educated and financially independent, an imbalance is emerging where men are often unprepared to accept this shift, leading to increased litigation. She emphasized that family court lawyers must be conscientious and responsible, recognizing the sensitive nature of such cases and the evolving social context.

In continuation of Advocate Vasundhara Nagraj's views, Dr. Aparna, Faculty Principal of PG College of Law, expressed her agreement and emphasized the significance of gender justice, as consistently upheld by the Supreme Court. She highlighted that gender justice is a crucial aspect of the legal system and expressed hope that the seminar would enlighten everyone on this important and timely topic.

Advocate Ameera Pasha, a fourth-generation lawyer, shared her professional journey, highlighting the challenges she faced without mentorship, even within a family of lawyers. With no formal mentor, she found guidance from court staff such as bench clerks, superintendents, and stenographers. She emphasized that today, gender barriers affect both men and women, and no gender holds a monopoly over struggle or bias. She also acknowledged the significant role the Supreme Court has played in addressing and mitigating gender bias in the legal system.

Total 18 papers were presented in the technical session :III

Speakers presented on Gender Reforms which includes Reproductive rights of Women, stressed the need for a Gender neutrality cited techie "Atul Subash" case, Section 69 of of Bharatiya Nyaya Sanhita, 2023 stated that inducement for, or false promise of marrying by suppressing identity shall be punishable offence.

Speakers also presented their papers on various facets of law comprising Criminal administration of justice, Right to Information Act, Labour Rights, Corporate Governance, Corporate Social Responsibility and Application of Environmental, Social and Governance (ESG). Speakers addressed questions from the panel of Judges and audience for which appropriate answers were given along with valuable insights and Supreme Court Citations. The Session concluded with key takeaways and suggestions from the session chairs with thought-provoking debates.

Court Visits



COURT OBSERVATION REPORT
LL.B. III Year Students (7th April – 11th April, 2025)
City Civil Court & Family Court, Kalapathar, Hyderabad

As part of the academic curriculum for LL.B 3rd-year students, a Court Observation Program was organized from **7th April to 11th April 2025** at **City Civil Court and Family Court, Kalapathar, Hyderabad**. The primary objective of this program was to familiarize students with practical aspects of court proceedings, court decorum, and legal procedures. The court proceedings began sharply at **10:30 AM** each day.

1. Discipline and Behaviour in the Court Hall

Students witnessed and strictly adhered to the code of conduct and decorum maintained within the courtroom. Observations included:

- Mobile phones were strictly prohibited inside the courtroom.
- Silence was maintained throughout the proceedings.
- Proper dress code and respectful behaviour towards the judges and court staff were strictly followed.
- The importance of punctuality, respectful communication, and maintaining decorum was emphasized by court officers.

2. Call Work Observation

Students observed the **call work session** that marks the beginning of daily proceedings. This included:

- The court clerk calling out the case numbers and names of the parties and advocates.
- Brief mention of the case status (e.g., for hearing, for adjournment, for evidence).
- Advocates appearing and reporting on behalf of parties.
- Adjournments and court directions were issued accordingly.

This session helped students understand the workflow and scheduling system of the court.

3. Evidence Recording

During the court observation, students had the opportunity to witness **recording of evidence**, which included:

- Examination-in-chief, where the witness gives his/her statement under oath.
- Cross-examination by the opposing counsel.
- Importance of documentation and maintaining court records during evidence.
- Role of the presiding officer in directing questions and maintaining fairness.

This process allowed students to understand how evidence is formally presented and tested in court.

4. Trial Procedure

The students closely followed various stages of **trial proceedings**, including:

- Opening statements by the prosecution and Défense.
- Presentation of evidence and witness testimonies.
- Legal arguments and application of law to facts.
- Pronouncement of orders and judgments.

Through this observation, students gained practical insight into how theoretical legal concepts are applied in real courtroom scenarios.

5. Section Work and Legal Procedures

Students were also exposed to **section work**, which included:

- Observing how legal provisions (from IPC,BNSS,BNS, CrPC, CPC, etc.) are invoked and interpreted.
- Filing of applications and interim petitions.
- Understanding how procedural laws guide the conduct of court proceedings.

Conclusion

The Court Observation Program provided LL.B. 3rd-year students with invaluable exposure to the functioning of civil and family courts. The disciplined environment, systematic proceedings, and real-time application of legal procedures helped students bridge the gap between theoretical knowledge and practical application. Overall, the experience strengthened their understanding of court practice and instilled a deep respect for judicial processes.

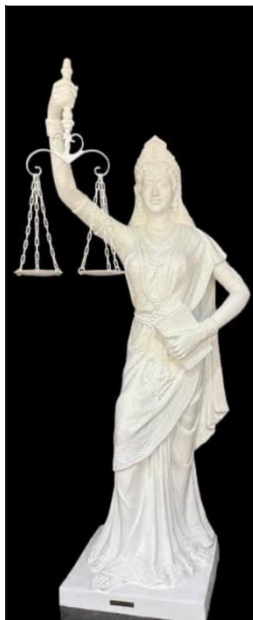

REPORT ON LEGAL AID CAMP HELD ON 28TH JUNE,2025 AT ATTAPUR, RAJENDERNAGAR.

Marwadi Siksha Samithi Law College conducted a Free Legal Aid Camp on 28th June, 2025 between 10.45 am to 2 pm at Ram Mandir Premises, Rambagh, Attapur, Hyderabad. M.S.S. Law College

The Constitution of India under Article 39A promotes Equal Justice and Free Legal aid to all sections of the society with an emphasis on the grievances of the weaker sections who are living below poverty line so as to ensure opportunities for securing justice are not denied to any citizen by reason of economic or other disabilities. The College Principal reiterated that this Free Legal Aid Camp is intended to address grievances of all sections of the society so as to explore legal remedies to their various disputes on different subjects of Law

Sri. Ravi Kumar garu who is a defense counsel in the Ranga Reddy District Legal Services Authority, while addressing the Law Students said that they should inculcate advocacy skills and discussed the provisions relating to Legal Services Authority Act, 1987 which paved the way for establishment of The National Legal Services Authority, and similar institutional framework at State and District level. He advised Law Students to participate in mega Lok Adalat and to conduct mediation proceedings between the disputing parties which are available as Alternative Dispute Resolution at various courts across Telangana State

Sri. M. Rangaiah garu said that he has conducted Free Legal Aid Camps on behalf of M.S.S. College for the past three years. Sri. Rangaiah garu a seasoned and an experienced Advocate who is representing various disputes at High Court and District Courts. He shared his past experience of resolving the legal disputes covering land grabbing issues, matrimonial disputes, abuse of IPC Section 498A and outlined Section 200 CrPC / Section 223 BNSS now envisaged lodging of Private Complaints before the Magistrate or by lodging a Zero-FIR stipulated in Bharatiya Nagarik Suraksha Sanhita, 2023 which can be transferred to the respective jurisdictional police station for further redressal.

Smt. Parvathi garu, Sub-inspector of Police, P.S. Attapur said that we take strict precautions while registering FIR and filing Charge sheets in compliance with the provisions prescribed under BNSS. We also accord highest priority to any complaint received at the P.S. Attapur in pursuit of justice to the victim.

Smt. Mondra Sangeetha garu Attapur Division, GHMC Corporator in her address said that this legal aid camp would help the residents to address their grievances in order to explore suitable legal remedies. She stressed the need that this kind of Legal Aid Camps are essential to provide legal awareness about citizen's rights and to get legal relief. We are fortunate that this camp is being conducted by dignitaries and advised public to avail this opportunity.

Later on, Sri. M. Rangaiah garu declared Free Legal Aid Camp OPEN to all the Citizens, Law Students and to the public.

As part of this Legal Aid Camp an awareness program was also conducted by EMRI Green Health Services Ambulance Staff Mr. Praneeth, Advanced EMT, Mr. Srinivas – Pilot and Mr. Suresh - Pilot explained about the Emergency Response Service i.e “108” Ambulance Services and “102” Pregnant Woman Transport Services being offered by the Government of Telangana since 2005 and 2018 respectively. “108” has a fleet strength of 488 ambulances across Telangana and “102” has a fleet strength of 300 vehicles. They have explained the process of availing these services and the scheme features includes deployment of ambulances at various hotspots, attending to the complaints in the golden hour and admission of the patient in trauma and other emergency cases to the nearest Govt Health Facility.

Activities Conducted and Legal Issues Addressed

Legal awareness session (Rights of Women, Senior Citizen, Labour Laws, Civil Disputes, etc Sri. Jyoti Rao, Sri. Chavan Gopal and Sri. B. Praveen raised their land disputes in detail and suggested legal options to initiate legal proceedings on the land grabbing, Suit for Declaration under Specific Relief Act, 1963.

Ms. Uma raised her grievance relating to property disputes which were suitably addressed by the camp in relation to the provisions of Hindu Succession Act and Transfer of Property. Several other residents and Law Students raised expressed concern on the abuse of Family Law Provisions and camp suggested suitable legal remedies. Sri. Jyoti Rao said that he had paid advance to an builder for construction of a structure as per the Contractual agreement, but the builder ran away and left civil works in the incomplete stage. Law Faculty suggested that a Suit for Specific Performance can be initiated after verification of documents viz., contract agreement, Advance payment receipts. The Free Legal Aid Camp resulted in grand success which was attended by 150 persons comprising local residents, aggrieved persons, Law Students, and the neighboring Public shown keen interest.

Conclusion: summary of Camp’s success The Free Legal Aid Camp concluded with the vote of thanks by M.S.S. Law College and expressed pleasure over the successful active participation of all the stakeholders of the law and the spirit of legal aid enshrined in the Constitution of India taken forward to a new height.
